# Food Vendor Contract

## 2022 Gran Festival North Iowa

### DETAILS:

EVENT DATE/TIME: June 4, 2022 12:00pm-9:00pm

EVENT LOCATION: Bandshell Park, Highway 3 Downtown Hampton, Iowa

### SETUP TIMES:

Fri, June 3 6:00pm-8:00pm

Sat, June 4 9:00am- 12:00pm

**FEE:** \$150, due with signed contract no later than May 15, 2022.

**MANDATORY BOOTH OPEN TIME:** Trucks/booths must be staffed by noon on Saturday and must be staffed at all times during the festival.

**LOAD/UNLOAD:** All food vendors will be located on the west side of Bandshell Park. Vendors may unload and load vehicles on the street near designated booth location (DO NOT DRIVE IN THE PARK). All vehicles must be moved immediately – cannot remain in place during set up/tear down. Free public parking is available near the venue.

**INSURANCE:** All food vendors must provide proof of insurance as well as a copy of the temporary food establishment license issued by the State of Iowa. No food vendors will be allowed to operate or sell at the Festival without providing both insurance and licensing.

**CANCELLATION** of Event Policy by Gran Festival: ***Event will take place rain or shine.*** Should a weather-related cancellation occur, vendors will be notified by 7am on June 4, 2022. Half of the vendor fee will be refunded for weather-related cancellation. If Gran Festival North Iowa should cancel the event for other reasons, the entire deposit will be returned to the Vendor within 30 days of cancellation notice.

**BY VENDOR:** All fees will be forfeited by vendor if VENDOR cancellation occurs after May 15, 2022.
